

The Mediapolis City Council met in regular session on 6/17/19. Mayor Riherd called the meeting to order at 6:30 PM. Present – Doyle, Licko, Kerr, and Garrison. Absent – Massner. Visitors – Mike Bergren, Dale Gorham, Greg Cromer, Jeremy Dean, Chris Peterson, Larry Krieger, Jessica Cary, Rob Rhum, and Sergeant Glendening.

Motion by Garrison seconded by Doyle to amend and approve the agenda to add two building permits under the consent agenda and resolution 22-2019 to transfer city funds. All ayes.

Motion by Doyle seconded by Garrison to approve the Consent Agenda – Minutes, Expenses, Clerk, Library and Water Reports. Approve Cigarette Permit for Dollar General and Mepo Foods. Approve a Building Permit for a Storage Shed at 1360 Pine St. – Tony Esslinger. Approve a Building Permit for a Storage Shed and Deck at #7 Jacara Dr. – Dawn Wanfalt. All ayes.

Dean and Peterson would like to see the council look into allowing ATV/UTV's in town. The council will be forming a sub-committee to discuss further.

Sheriff's report presented by Sergeant Glendening.

Greg Cromer presents the council with an aerial photo view of the City. Motion by Doyle seconded by Garrison to purchase a 20x28 framed aerial photo of the City of Mediapolis. All ayes.

Rhum presented the council with a pool update.

Mayor Riherd opened the Public Hearing at 6:45 PM on the change in zoning from R1-A to C-1 for Parcel #02-26-401-010.

Motion by Licko seconded by Kerr to approve Two Rivers Property Insurance of \$34,334 for the City of Mediapolis for FY 19/20. All ayes.

Motion by Doyle seconded by Garrison to leave Utility Rates as is for FY 19/20. All Ayes.

An ATV/UTV sub-committee was established including Riherd, Siegle, Doyle, and Garrison.

Mayor Riherd closed the Public Hearing at 6:49 PM.

Motion by Garrison seconded by Doyle to approve **Resolution 21-2019 to approve the Software Agreement Contract with GIS Workshop, LLC d/b/a gWorks.** After a unanimous roll call vote, the Mayor declared the resolution duly adopted.

Motion by Garrison seconded by Kerr to approve **Resolution 22-2019 authorizing the City Clerk to Transfer Funds for Fiscal Year End 2019.** After a unanimous roll call vote, the mayor declared the resolution duly adopted.

Motion by Garrison seconded by Licko to approve the first reading of **Ordinance 341 by amending the Zoning Map of the City of Mediapolis by changing Parcel #02-26-401-010 from an R1-A to C-1.**

After a unanimous roll call vote, the first reading was approved. Motion by Doyle seconded by Licko to waive the second and third reading and adopt it that night. The motion was approved after a unanimous roll call vote and the Mayor declared the Ordinance duly adopted. It will go into effect after publication, as required by law.

Motion by Doyle seconded by Kerr to table 5-2019. All ayes. Motion by Garrison seconded by Doyle to send a 7-day letter to 7-2019. All ayes.
